- Results Caching
 - Database query results (filter and report combination) are now cached in the file system
 - o Cached results are always cleared after a Virtual Patient Recalculate and/or Report Recalculate
- Virtual Patient Recalculate and Report Recalculate
 - Odde has been revised to use disk space (temporarily) to prevent memory pressure during heavy calculation
 - Important
 - Please have at least 50-100GB of disk space in the PATCAT web server at all times
 - By Default, the temporary files are stored under the PATCAT website folder. If you wish to change this, please let us know
 - Only schedule re-calculations outside business hours (preferably before weekends)
- Update Scheduling
 - PATCAT will only allow PHN users with the following PenCS portal permission to schedule a PATCAT and/or PAT-BI update

- PIP QI Email Receipt and Reminders
 - In the event that SMTP details are incorrect and emails cannot be sent, receipt and reminders will be resent when a valid SMTP details are provided
 - Reminder emails will only be re-sent to practices that have not submitted a PIP QI Compliant extract for the quarter
- Login Audits
 - All login attempts (success or failure) are now logged

- Show/Hide Columns functionality
 - Selections are now saved against the user and report(s)

- Waist measurement report has a new category for "< 18yrs Not Recorded"
 - For older extracts a recalculation will be required to show the new report category
- Spirometry report title updated to reflect that reports POST data only
- PAT Cleansing Indicated Condition Reports will exclude patients that have been reviewed by the practice as not having the condition
- O This information will only be available from CAT4 V4.15 onward, a recalculation is required to see this information in the relevant report
- Import Service Improvements
 - Revised code to help recover when database server is unavailable and/or unexpected errors occur
 - Extract import is given high priority over most automated processes
 - Some automated processes will abort execution when it detects there are extracts in the Request Queue

To see the updated numbers a recalculation for this report has to be done first.
