




When a patient eligible for influenza vaccination who has not yet been vaccinated this calendar year according to clinic records presents for a consultation, the **FLU** app uses a simple notification system based on the Australian Department of Health recommendations and NIP eligibility criteria to alert you.

Strongly recommended for vaccination, **NOT** NIP funded




Recommended for vaccination **NOT** NIP funded

A notification alert automatically appears on the FLU app on Topbar when a patient has yet to be vaccinated this season*
